I wanted to share with everyone information regarding the 2024 TEEA Scholarship opportunities for our 4-H members in District 1.

1. ***District 1 Texas Extension Education Association Scholarship*** will be awarded to 2 qualifying D-1 4-H members if funds allow. The winner will be awarded in the amount of \$1,000.00. All D-1 4-H members are eligible. The application is attached. The winner(s) will be announced during the District 1 TEEA meeting in April. **The application should be postmarked by March 1, 2024 and to:**

1. The criteria for this scholarship are:
  - a. 4-H applicant must be a member in good standing in District 1 4-H.
  - b. Must be a graduating senior planning to enter college in the summer or fall of the coming year.
  - c. Must have an accumulative grade average of 86.
  - d. Must be a District 1 resident.
2. **Only one applicant from each county may be sent on the district level to be judged for the district recipient.** If you have more than one county applicant, I would encourage you to utilize the state score card in having your county applications judged.

2. ***The District 1 Texas Extension Education Association Collegiate Scholarship*** will be awarded in the amount of \$500.00. The application is attached. The winner will be announced during the District 1 TEEA meeting in April. **The application should be postmarked by March 1, 2024 and sent to:**

1. Criteria for the scholarship are:
  - a. Must be completing at least 24 hours at time of application.
  - b. Must have an accumulative grade average of 2.5.
  - c. Must have been a District 1 resident during High School.
  - d. Must have been a District 1 4-H member as a Sr. 4-H'er or a child or grandchild of District 1 EEA.

3. The ***Texas Extension Education Association 4-H Scholarship*** is state awarded. I have attached the guidelines, application, and score card. Please note that this scholarship requires a copy of the member's record book, application, and reference letters. A copy of the application is located on the pages 12-6, 12-7, 12-8 of the TEEA manual of the TEEA website (<http://teea.tamu.edu>). The winner will be announced at the District 1 TEEA Spring Conference meeting in April. The winner will be awarded in the amount of \$1,500.00. **This application is due in the respective County Office by February 15, 2024. The applicant selected from your county and required materials are due to Andrea -, of the TEEA manual on the Woolley, D-1 TEEA Director, Andrea Woolley by March 1, 2023.**
